The current headquarters, inaugurated in 1991, occupies 11.200 m² and is located on Granada's Cartuja University Campus. The School's physical and technological infrastructures facilitates its teaching activities and enables it to respond to the diverse needs of both professionals and students. The School has 9 classrooms equipped with multimedia resources and internet connections, a computer classroom with 32 workstations, a video conference system, a computer network composed of 200 work stations, auditorium for 300 pax and two booths for simultaneous interpretation, rest areas for students and guests, a cafeteria that can handle up to 200 persons and that regularly serves an average of 150 meals daily, a fitness centre, 150 parking slots, and a library. Furthermore, the EASP has a Virtual Campus since 2004 to conduct online sessions that complement courses offered on campus, thus making courses more accessible to interested professionals. The EASP's virtual campus houses several different platforms that facilitate collaborative project management.

Library

The library specialises in public health with a particular emphasis on healthcare management, statistics, epidemiology, research, health promotion and medicinal drugs. The collection contains 60.700 records and access to 2.400 online journals. Bibliographical searches in biomedical databases are also available. The library is World Health Organization-Europe (WHO-Europe) documentation centre since 1996 and holds up-to-date collection of all WHO publications. Furthermore, EASP's library is part of the Virtual Library of the Andalusian Public Health Service. The library also includes the Documentation Centre for Cooperation, which offers specific documentation and information services regarding this issue.

Publications

EASP publishes specialised books on public health and healthcare management compiled from the School's educational, research and consultancy activities by EASP staff and associates. This places the School's intellectual output at the disposal of facility managers, professional healthcare managers and care providers alike, as well as patients and the public at large. All EASP Publications are available on the School's webpage, www.easp.es, and can be downloaded as PDF files.

Granada Cancer Registry

The Granada Cancer Registry (GCR) is a population-based cancer registry, which began its activity in 1985 as a project under the auspices of the Ministry of Health of the Andalusian Regional Government, attached to the Andalusian School of Public Health. Data are collected from patients living in the province of Granada and diagnosed with cancer since January 1985. This allows understanding cancer incidence in Granada, time trends in incidence and survival of patients. This information is useful for cancer surveillance and control in Granada and serves as a basis for cancer epidemiological research. The GCR is a member of the European Network of Cancer Registries (ENCR) and the International Association of Cancer Registries (IACR), and takes part in activities coordinated by the International Agency for Research on Cancer (IARC). The GCR is also part of the Spanish Network of Cancer Registries (REDECAN), established in 2010. It is one of the twelve Spanish population-based cancer registries to have their data published in consecutive editions of the Cancer Incidence in Five Continents series of monographs, an international reference for Population-based Cancer Registries published by the IARC. The Granada Cancer Registry conducts research projects on descriptive epidemiology and cancer risk factors, as well as on health care and outcomes assessment in cancer patients. On the other hand, we are one of the research groups that make up the CIBER in Epidemiology and Public Health (CIBERESP). The Granada Cancer Registry, since its startup, has developed research projects produced by the GCR itself or in collaboration with other national or international institutions, along three main lines:

- Descriptive epidemiology of cancer
- Risk factors for cancer and other chronic diseases
- Health care and outcomes assessment in cancer patients

The quality levels achieved by the GCR's activity over 25 years and the addition of a major component in research excellence, has expanded the nature and scope of the Granada Cancer Registry as an information system in such a way that it could be considered a Cancer Research Unit.

Following contacts and the invitation to steer the Spanish language HIFA Forum led by WHO since 2006, the EASP is involved in the design, organization, and coordination of this HIFA FORUM of the Global Health Information network, under WHO supervision.

The Spanish HIFA FORUM will follow the HIFA Global Health Vision and Strategy by trying to respond to health information needs of the stakeholders in the Spanish language world, as well as facilitating their connectivity with the overall and specific HIFA Forums.
